# Donorships regulations

USDV U Dance 18 July2023



The donorship regulations are an addition to the By-Laws. It describes the categories of donors, and the rules and conditions regarding donorship such as terms and payment procedure.

## Article 1 Categories

### Category A

Yearly contribution: 30,-

- Admission to the annual final barbecue
- Sign up for xTDS
- Donorship pin
- Monthly newsletter (if desired)

### Category B

Yearly contribution: 40,-

- Access to technique classes
- Free admission to social dancing
- Access to U Dance camp\*
- Access to the annual final barbecue
- Sign up for xTDS
- Donor pin
- Monthly newsletter (if desired)

#### Category C

Yearly contribution: 50,- or more

- Member rate for gala tickets
- 20% discount on requested workshops\*\*
- Listing on website, member portal and/or yearbook(if desired)
- Access to technique classes
- Free admission to social dancing

- Access to U Dance camp\*
- Access to the annual final barbecue
- Sign up for xTDS
- Donor pin
- Monthly newsletter (if desired)

\* Members have priority

\*\* No stacked discounts

### Article 2 Direct debit authorization

1. By issuing the authorization for the donation, the donor authorizes the automatic collection of the amount corresponding to the chosen donorship category, due from the bank or giro account number specified by the donor. This is a continuous authorization, until termination of the donorship, whereby the respective donor gives permission to debit the amount due for the donation each subsequent year.

### Article 3 Payment procedure

- A few weeks before the donation is to be debited, the donor will receive an email with further details regarding the collection procedure. The donor will receive a reminder notification no later than 7 days before the collection is due.
- 2. The donor must ensure that at the time of collection of the amount due there is sufficient balance in the specified bank or giro account number.
- 3. If the collection is not successful, a payment reminder will be sent by one of the board members. The payment reminder will request that the amount due still be transferred within 2 weeks. Failure to pay will result in the cancellation of the sponsorship.
- 4. Payment is made annually by direct debit unless otherwise agreed in writing with the board. If a person becomes a donor after the joint collection time, the payment will be

made once at that time and will go along with the following years at the joint collection time.

## Article 4 personal detail changes

 Donor personal detail changes such as address, contact information and bank account number should be communicated in writing to the association secretary as soon as possible (secretaris@usduvdance.nl).

## Article 5 Termination donorship

 Termination of donorship should be communicated in writing to the secretary of the association (secretaris@usdvudance.nl). Due to the direct debit, this should be done before August 1 of the relevant academic year.

## Article 6 Amending donorship regulations

 Changes to the donorship regulations can only be made for the succeeding year and will be communicated to all donors via email no later than 14 days before August 1.
